LEGAL BASIS

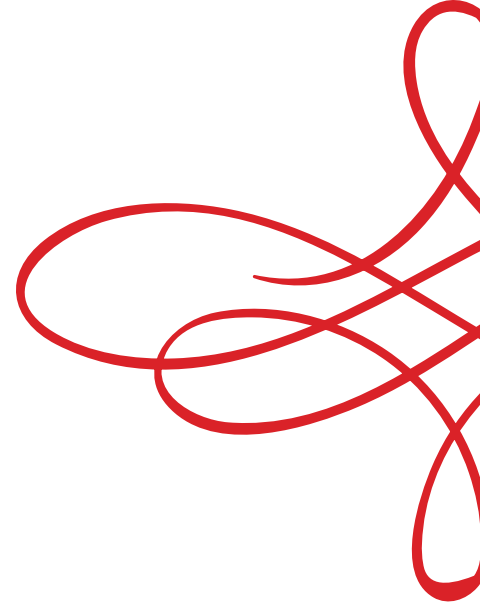

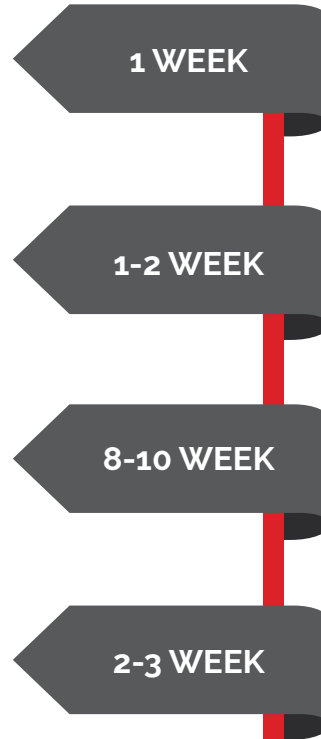
